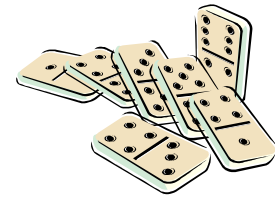

Motion by Roberts to accept the agenda as suggested. Second. Motion passes unanimously.

Motion by Tinsley to hold two Pro Tournaments on May 10 and Aug 23 in Hillsboro. Second. Motion passes unanimously.

Discussion of known tournaments and general yearly schedule briefly held. No decisions were made.

Motion by Summers to hold the TOC Dec 6 in Hillsboro. Second. Motion passes unanimously.

Motion by Tinsley to hold a logo design contest. Second. Motion passes unanimously.

Motion by Summers to change the wording of Tournament Hosting Information #3 from "must be willing to give" to "should provide". Second. Motion passes unanimously.
